Title VI Complaint Procedures

As a recipient of federal dollars, Central California Nikkei Foundation dba Vintage Gardens is required to comply with Title VI of the Civil Rights Act of 1964 and ensure that services and benefits are provided on a non discriminatory basis. Central California Nikkei Foundation dba Vintage Gardens has in place a Title VI Complaint Procedure which outlines a process for local disposition of Title VI complaints and is consistent with guidelines found in the Federal Transit Administration Circular 4702.1B, dated October 1, 2012.

Any person who believes she or he has been discriminated against on the basis of race, color or national origin by Central California Nikkei Foundation dba Vintage Gardens may file a Title VI complaint by completing and submitting the agency's Title VI Complaint Form. Central California Nikkei Foundation dba Vintage Gardens investigates complaints received no more than 180 days after the alleged incident. Central California Nikkei Foundation dba Vintage Gardens will only process complaints that are complete.

Within 10 business days of receiving the complaint, Central California Nikkei Foundation dba Vintage Gardens will review it to determine if our office has jurisdiction. The complainant will receive an acknowledgement letter informing her/him whether the complaint will be investigated by our office. Central California Nikkei Foundation dba Vintage Gardens has 30 days to investigate the complaint. The complainant will be notified in writing of the cause to any planned extension to the 30-day rule.

If more information is needed to resolve the case, Central California Nikkei Foundation dba Vintage Gardens may contact the complainant. The complainant has 10 business days from the date of the letter to send requested information to the investigator assigned to the case. If the investigator is not contacted by the complainant or does not receive the additional information within 10 business days Central California Nikkei Foundation dba Vintage Gardens can administratively close the case.

A case can be administratively closed also if the complainant no longer wishes to pursue their case. After the investigator reviews the complaint, she/he will issue one of two letters to the complainant: a closure letter or a letter of finding (LOF). A closure letter summarizes the allegations and states that there was not a Title VI violation and the case will be closed. An LOF summarizes the allegations and the interviews regarding the alleged incident, and explains whether any disciplinary action, additional training of the staff member, or other action will occur. If the complainant wishes to appeal the decision, she/he has 10 business days after the date of the letter of the LOF to do so.

A person may also file a complaint directly with the Federal Transit Administration, at FTA Office of Civil Rights, 12 New Jersey Avenue SE, Washington, DC 20590.
